

COVID-19 Liability Release Waiver

The World Health Organization has declared the novel Coronavirus (COVID-19) a worldwide pandemic. Due to its capacity to transmit from person-to-person through respiratory droplets, the Government of the host State of this event (the "Government") has set recommendations, guidelines, and prohibitions, which the Space Generation Advisory Council (the "Organisation"), and its Partners adhere to comply.

In consideration of my participation in the foregoing, the undersigned acknowledge and agree to the following:

- o By physically participating in the activities of the Organisation, I am aware of the existence of the risk to me, and to those with whom I interact with directly or indirectly, of injury or illness such as, but not limited to Influenza, MRSA, or COVID-19 that may lead to paralysis or death.
- o I, or any member(s) of my household, have not been diagnosed with, demonstrated any symptoms, including fever, fatigue, difficulty in breathing, or dry cough, or have in any way been exposed to any communicable diseases, including but not limited to COVID-19, within the past 30 days.
- o I, or any member(s) of my household, have not travelled to any areas not recommended by the Government within the past 30 days.
- o I, or any member(s) of my household, have not visited any areas reported to be highly affected by COVID-19, in the past 30 days .

Following the pronouncements above, I hereby declare the following:

- o I am fully and personally responsible for my own safety, and the safety of those whom I interact with directly, or indirectly, and actions while and during my participation, and I recognise that I may, in any case be at risk of contracting COVID-19.
- o With full knowledge of the risks involved, I hereby release, waive, and discharge the Organisation, its Partners, board, officers, independent contractors, affiliates, employees, representatives, volunteers, successors, and assignees from any and all liabilities, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of, or related to any loss, damage, injury, or death, that may be sustained by me, or those whom I interact with directly or indirectly, related to COVID-19 while participating in any activity while in, on, or around the premises or while using the facilities that may lead to unintentional exposure or harm due to COVID-19.
- o I agree to indemnify, defend, and hold harmless the Organisation and its Partners, from, and against any and all costs, expenses, damages, lawsuits, and/or liabilities or claims arising whether directly or indirectly from, or related to any and all claims made by or against any of the released parties due to injury, loss, or death from or related to COVID-19.

By accepting, I acknowledge that I have read the foregoing Liability Release Waiver and understand its contents; that I am at least eighteen 18 years old and fully competent to give my consent; That I have been sufficiently informed of the risks involved and give my voluntary consent in signing it as my own free act and deed; that I give my voluntary consent in signing this Liability Release Waiver as my own free act and deed with full intention to be bound by the same, and free from any inducement or representation.

This waiver will remain effective until laws and mandates relevant to COVID-19 are lifted.
